### **An Interview with Matthew Brower '04**

### Q: Describe your current position.

A: As Executive Director of the Montana Catholic Conference I represent the Roman Catholic Bishops of Montana on matters of public policy before state and federal lawmakers, including state legislators, our governor, our congressional delegation and various administrative agencies. Yes, this means part of my work involves lobbying. But, that's a minority of what my job entails and the lobbying I do may look quite a bit



different from what most people envision when they think of lobbying.

I advise the bishops on policy issues especially when and where they intersect with Catholic social teaching. This requires a reasonable amount of time researching issues and networking with others engaged in the same or similar work.

My role really is somewhat that of a diplomat in addition to advocate. I serve as a liaison to various other groups and individuals including the United States Conference of Catholic Bishops, Catholic Relief Services, Catholic Charities, the National Diocesan Attorneys Association and many others. In addition, I devote a significant amount of time to formation efforts helping to educate Catholics regarding public policy positions and the Church's social and moral teachings and I serve as resource for others engaged in formation, catechesis and communications.

### Q: How did you come to acquire this position?

**A:** At the time I transitioned to my current position, I was busy running my own law practice in northwest Montana—a solo practice I had opened 6 years earlier. Prior to attending law school I was employed for a number of years in parish ministry at a Catholic parish in west Michigan. Around 2012-13, I was growing increasingly frustrated with what I saw happening in policy and politics and I was looking for a way to combine my background in Church-related work with my legal training and experience.

Out of the blue, the executive director position at the Montana Catholic Conference came open in the fall of 2013. At my wife's urging, I decided to apply but wasn't overly optimistic given my lack of specific experience in policy work. But God writes straight with crooked lines and within a couple of months of applying I accepted the position and closed up my practice. I

haven't looked back or regretted for a moment the decision my wife and I made.

# Q: What do you find most challenging about working in your position?

**A:** Sometimes with public policy work it can feel as though progress is hard to come by and things are derailed by partisan politics. The political atmosphere can be rather toxic and trying to advance the common good in that climate can be daunting and discouraging at times.

Also, the Montana Catholic Conference currently has a staff of only one (me). As one who enjoys functioning as part of a team, this can be challenging. Most people (Catholics included) don't really understand what I do and many are turned off by anything associated with politics.

The colleagues with whom I work closest and who understand the day-to-day challenges and joys of this job are my fellow Catholic conference directors. Despite the fact we are able to gather only a couple of times each year we share a strong bond. Those connections and friendships help carry us through when things get difficult or unpleasant. In politics that's not uncommon.

### Q: What do you love about working in your position?

**A:** The work is challenging, always changing and intellectually stimulating. There's such a range of complex issues with which I get deal there's always a need and opportunity to learn more. I get to collaborate with and learn from wonderful people who are experts and influencers in their various fields, including law.

I find my work quite fulfilling. It makes it easy to go to go to the office when the very nature of one's work entails standing up for human life and dignity and working to promote the common good

# Q: What's your personal philosophy on your work as the Executive Director of the Montana Catholic Conference?

**A:** I think professional success requires confidence, but humility is also essential. Always be willing to learn from others and continue to grow in knowledge, wisdom and prudence. One's work provides an opportunity to witness to the truth and grow in holiness. And remember, your work is not the most important thing. Keep it in proper perspective.

# Q: Tell me about someone or something that has influenced your decision to work in your position?

**A:** Back in 2013, a friend of my in-laws, Dr. Robert Kennedy (Professor of Catholic Studies at the University of St. Thomas) suggested that with my background and interests I should look at employment opportunities at a

state Catholic Conference. The challenge, he said, was finding an opening at a conference as those jobs were very desirable and people rarely left the position.

Providentially, within a couple months of that conversation, my predecessor (a friend and mentor to me to this day) decided to take a new position and the executive director position came open.

# Q: What would you tell someone who is thinking about working in your profession/field?

**A:** I love my job and find the challenges invigorating. If you think you might be interested in pursuing a career in public policy it might be helpful to get a taste of that type of work through internships, volunteer opportunities, etc. The tasks and day-to-day responsibilities are quite different from what one experiences in a traditional law practice.

That being said, lack of experience in public policy should not deter one from pursuing that career path. Many skills developed in legal practice are extremely useful in policy work.

Just as we need good attorneys in the legal profession, we also need good people working in policy and politics.

I am always happy to share my experiences and insights with others who might be interested in work similar to mine. Just call or email!

### Q: What do you do when you aren't working?

**A:** My wife (Miriam) and I have a 5 year-old and a 3 year-old so when I'm not busy with conference responsibilities I'm busy with family. We are blessed to have a huge network of friends who have children around the same ages so we are always doing fun family things as a group (birthday parties, barbeques, etc.).

Living in Helena, Montana there's no shortage of opportunities to enjoy all the great outdoors has to offer. Though, I embarrassingly have to admit I still have not taken up fly fishing.

I always find time to cheer on the University of Notre Dame (my alma mater) whether on the football field or the basketball court. And I still root for all my hometown (Detroit) sports teams.

# Q: How has your experience at Ave Maria School of Law prepared you for your position?

**A:** The academic rigor of AMSOL and an environment that encouraged intellectual inquiry helped me develop an ability to analyze and understand

complex issues. It also helped instill in me a greater confidence in my professional abilities. That, in turn, has allowed me to take bold steps opening my own law practice and then transitioning into a new line of work with my current position. The grind and demands of law school required me to develop discipline and an ability to prioritize while juggling multiple responsibilities. All of my law school courses and professors were top-notch and I think there's probably something I learned from each one of them that I have benefited from and carry with me to this day. But, there were four professors and courses that profoundly impacted me and specifically helped equip me for the work I do today—Mollie Murphy (Torts), Richard Myers (Constitutional Law), Stephen Safranek (Law, Ethics & Public Policy) and Charles Rice (Jurisprudence).

**Q:** Do you have anything you'd like to share with fellow alumni? **A:** Particularly for those who are recent graduates, don't worry about having your entire law career planned out in detail at this point. Follow a well-discerned path but don't be afraid to move in a new direction, whether that's solo practice, government employment, politics, etc. Most likely, the skills you've learned in law school will in some way benefit you regardless of your line of work. If you think you might be interested in public policy, don't hesitate to contact me.

### Ave Law's Day of Giving






